- Transaction expresse measures changes in the value of outstanding financial obligations incurred
 prior to a change in exchange rates but not due to be settled until after the exchange rates change.
 Thus, it deals with changes to each flows that result from existing contracted obligations.

Transaction exposures are existing exposures of the firm, resulting from identifiable transaction. Operating exposures are exposures that are likely—anticipated—but not yet existing or contracted.
