

- Service Tax was chargeable under Section 66 of the Finance Act, 1994.
 'There shall be levied a tax at the rate of 12% of the value of the taxable services.....'
 - Taxable services being defined under Section 65
 - Significantly, there was no reference in charging section w.r.t place where service performed
 - Place of provision of service was being determined as follows:
 - In the case of Import- Section 66A read with Taxation of Services (Provided from outside India and received in India) Rules, 2006
 - In case of Export- Export of Service Rules, 2005.
 - Under the Pre-2012 regime, import of service was chargeable to service tax under "reverse charge mechanism"
 - Export of service was exempted from service tax.
