- A professional person is defined by C.R.S. §27-65-102 (17)
  - A person licensed to practice medicine in this state, a psychologist certified to practice in this state.
  - Or a person licensed and in good standing to practice medicine in another state or a psychologist certified to practice and in good standing in another state who is providing medical or clinical services at a treatment facility in this state that is operated by the armed forces of the United States, the United States public health service, or the United States department of veterans affairs.
