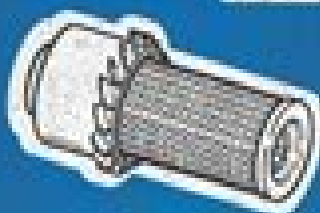
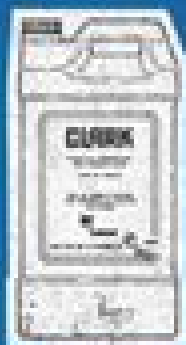

When using the machine serial number, use the complete number. The complete number contains three sets of numbers and letters. The first contains four numbers. These four numbers are the loader model and engine identification numbers. The second set has one to three letters which show the location of the manufacturing plant. The third set has five numbers which show the production sequence number (Fig. 1).

The number shown in the quantity column in this manual is the number of parts needed for the illustration on that page. For some parts an "x" will be shown in the quantity column. This "x" indicates that the quantity to be used is "As needed".

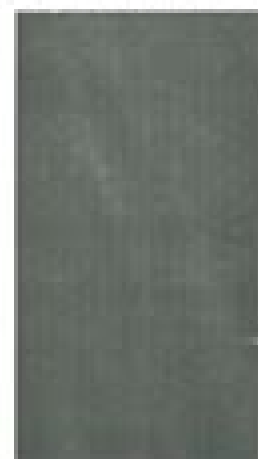
When references R.H. and L.H. are used in this manual, it is done from the operator's seat in the forward operating position.
